

# VIRTUAL TRAINING POLICIES AND AGREEMENTS

# **ELIGIBILITY**

To maximize the potential for real change on a college campus, Alteristic utilizes a team approach to implementing Green Dot. This Virtual Green Dot Institute (GDI) is only open to campuses who are already implementing Green Dot. It is an opportunity to add certified instructors to their team.

We recommend that team members include not only designated prevention/intervention staff, but also professionals across your institution like faculty, student affairs staff, and administrators. Any participants from agencies outside of a campus are required to attend in partnership with a local campus team. While outside agencies can provide much needed support and expertise, Green Dot is a campus mobilizing effort and must be led from within the institution.

Upon completion of the training you will be a Green Dot College Instructor. This means that you can implement the Green Dot Violence Prevention Strategy at your college, but does NOT mean that you can train other individuals or groups to implement the strategy. This training will not equip you to implement in middle schools, high schools, military installations, or your general community.

# TECHNOLOGY REQUIREMENT & RECORDING POLICY

For Virtual Green Dot Institutes, Alteristic utilizes the Zoom online platform. The technology requirements to participate are access to a computer with both audio and video capability and consistent internet service.

You may NOT record any portion of the Virtual Green Dot Training without written permission from Alteristic. You are NOT permitted to take photographs, screenshots, video or audio recordings of any portion of the training.

## **ATTENDANCE POLICY**

In a Virtual GDI, participants need to be online and present within the technology platform for the entirely of the four days in order to be certified as a Green Dot Instructor.

## COLLEGE USAGE AGREEMENT

This Usage Agreement (the "Agreement") is entered into between Alteristic, Inc, a Virginia not-for-profit corporation, having its principal office at 5680 King Centre Dr., Suite 600, ALexandria, VA 22315 ("ALTERISTIC") and you, the participant. You agree to adhere to the following guidelines.

1. Upon completion of the Instructor Certification Training, Alteristic grants you a non-exclusive, fee-free, revocable license agreement to use Alteristic's trademarks at your institution. You are also granted a non-exclusive, revocable license to use Alteristic's copyrighted materials. The instructor training certifies you to implement the Green Dot College Program at your

institution. You are not certified to train others to implement the program. You are not certified to implement the Green Dot strategy in settings other than college.

- 2. Only individuals who have received the Green Dot Instructor training from Alteristic trainers may present the curricular components of the program.
- 3. You MAY NOT alter the Green Dot curriculum in any way, except where specified within the materials for adaptation purposes.
- 4. The Green Dot strategy must be implemented in its entirety and independently (i.e., it may not be broken into pieces or integrated into other specific programming strategies).
- 5. Your training manuals may NOT be duplicated for any reason. Any program materials (including electronic materials and implementation kit items) may be disseminated for program implementation purposes only. Only the original recipient is authorized to utilize Green Dot materials.
- 6. All Green Dot designs may be used to create materials for use within your social marketing campaign. Materials bearing Green Dot designs may not be sold or distributed for purposes other than those supporting your Green Dot implementation.
- 7. With respect to the use of Alteristic's trademarks, you agree to use our trademarks properly and in such a way that does not negatively effect the value of our trademarks.
- 8. Either party may terminate this Agreement and the right to use Alteristic's trademarks and copyrighted materials by providing 30 days notice to the other party in writing.
- 9. Violation of any of these terms of usage can be considered a default of the license to use Alteristic's trademarks and materials, and Alteristic may terminate this license and Usage Agreement immediately upon notice to you.
- 10. If this Agreement expires or is terminated for any reason, your right to continue using Alteristic's trademarks shall immediately end. In the event of Termination, you shall be obligated to immediately cease any further use of Alteristic's trademarks and cease any further use of Alteristic's programs, materials, and curriculum, including Alteristic's copyrighted materials.
- 11. As Green Dot is evaluated, content improvements will be made. Instructors can expect an updated version of the strategy every 1-3 years. These updates will be available to all previouslytrained instructors.
- 12. You may not charge or collect payment for delivering any portion of the Green Dot curriculum, including but not limited to the overview talk, bystander training, social marketing campaign, or action events.
- 13. No part of the Green Dot curriculum can be used as a disciplinary measure. All content must be delivered as prescribed in the launch plan.
